Dr Pereira is the author and editor of several leading oil and gas textbooks: Brazilian Upstream Oil and Gas: A Practical Guide to the Law and Regulation (Globe Law & Business (GLB), 2012), Joint Operating Agreements: Controlling risks to the Non-operator (GLB, 2013), Upstream Law and Regulation: A Global Guide (GLB, 2013), Joint Operating Agreements: Mitigating Operational and Contractual Risks in Exclusive Operation (GLB, 2013), Encyclopaedia of Oil and Gas Law: Volume 1 (GLB, due March 2014), Brazilian Midstream and Downstream Oil and Gas: A Practical Guide to the Law and Regulation (GLB, due August 2014), Encyclopaedia of Oil and Gas Law: Volume 2 (GLB, due December 2014), African Oil and Gas Law and Regulation: A Practical Guide (GLB, due April 2015), Joint Operating Agreements: Challenges and Dynamics between NOC and IOC (GLB, due August 2015). He is an adjunct professor of energy law at the University of Eastern Finland Law School and an associate editor of OGEL.



#### Kim Talus

Professor of European Law, University of Eastern Finland (UEF)

Kim Talus is a Professor of European Economic and Energy Law at UEF Law School and the Director of the Center for Climate Change, Energy and Environmental Law (http://www.uef.fi/en/cceel). He is also a Professor of Energy Law at the University of Helsinki. His research and other activities focus on international, comparative and European energy law. More specifically, his activities focus on international upstream petroleum law and regulation and on EU energy law and policy. He has published widely in these areas and is a frequent speaker in international conferences. He has held teaching positions at University College London, University of Houston and Bonn University. He is the Editor-in-Chief for Oil, Gas and Energy Law (www.ogel.org) and a member of the Editorial Board for Journal of World Energy Law and Business. He works frequently with companies, public authorities and governments in various areas of energy law and policy. He is also an expert member (electricity) of the Finnish Market Court.



José Alberto Bucheb General Manager, Petrobras University Brazil

José Alberto Bucheb graduated in Geology at the State University of Sao Paulo and in Law at the State University of Rio de Janeiro, Brazil. He got a Master Degree in Geophysics at the Federal University of Para and a Master Degree in International Law at the State University of Rio de Janeiro. He also got his PhD in Geology at State University of Rio de Janeiro, Brazil. He authored the books: "International Arbitration in the Petroleum Industry" and "Petroleum Law – The Regulation of the E&P Activities in Brazil", both in Portuguese. He works for Petrobras, the Brazilian NOC, since 1980. Before assuming his current position, as General Manager of the Petrobras corporate University, he acted as the Joint Ventures Manager of E&P activities of the Brazilian Pre-salt.



Fernando Barata Alves Member of the Management Commission, Partex Oil and Gas

Graduated in Chemical Engineering from Faculdade de Ciências e Tecnologia of Universidade de Coimbra, he has a Master degree in Oil Engineering from the Imperial College of Science and Technology, London University.

He started his career in 1980 at Partex Oil and Gas group, and he worked in the Middle East in one of the operating companies in Abu Dhabi, where he was responsible for the management and study of several oil fields, coordinating the group that was in charge of the application of new production technology and maximization of oil reserves. He was involved in the implementation and supervision of projects of development of oil fields in the Middle East, West Africa, Siberia and Kazakhstan.

He led several technical departments, monitoring the oil studies and projects of the group, and representing the group in its participations in Abu Dhabi, Oman e Kazakhstan. He is a member of the Management Commission of Partex Oil and Gas, since 2004, with responsibilities in managing the referred participations and the investments in new projects of exploration and production.

He is co-author of the book "The Universe of Oil Industry", published by Calouste Gulbenkian Foundation in its collection of University Textbooks, now in its 3rd edition, of which is also published an edition in English.



Jorge Salgado Gomes General Manager, Petrobras University Brazil

Jorge Salgado Gomes holds a BSc and MSc in Geology from Oporto University, Portugal, and an MEng and PhD in Petroleum Engineering from Heriot-Watt University, United Kingdom. He has more than 30 years of oil and gas experience and during his career he worked for BP, EDMA, Qatar Petroleum, HOT Engineering, ADCO and PARTEX occupying many technical and managerial positions. He worked in Qatar, UK, Austria, Libya and Abu Dhabi. While working in Qatar, he was responsible for two gas discoveries (500 BCF). He also holds two international awards, one from SPE and another from the Petroleum Institute (UK), for innovative research work. He is a member of SPE, AAPG, EAGE, SCA and has published several papers in international conferences. He is the co-author of both Portuguese and English versions of the book entitled "The Universe of the Oil & Gas Industry", published by Calouste Gulbenkian and PARTEX Oil & Gas respectively, and the editor of the book "New Technologies in the Oil and Gas Industry", published by INTECH open science. He is currently a PARTEX Chaired Professor at the Petroleum Institute in Abu Dhabi, whilst working for both the Petroleum Engineering and GeoScience departments. Until very recently, he was the Senior Vice President for R&D at the Petroleum Institute. His field of expertise is reservoir characterization and modelling, full field development and assessment of oil and gas reserves.

Rui de Oliveira Neves has been a lawyer in the energy, corporate and capital markets area since 1999 and the energy law partner of the leading law firm Morais Leitão, Galvão Teles, Soares da Silva & Associados since 2009. Since June 6, 2013 he has been the General Director of Galp Energia Group and has been appointed Company Secretary of the major companies of the Group since July 26, 2013.

In the corporate and securities area he has lead the counseling of the reprivatisation of the largest Portuguese power company and the national TSO, as well as the IPO of the fourth largest worldwide renewables company, several tender offers, other IPOs and reprivatisation operations. In the energy law area he participated in the reorganization and liberalization process of the national energy sector initiated in 2003/2004, which involved, among others, the drafting/revision of several energy sector legislation, the early termination of Power Purchase Agreements, the negotiation of concession agreements for hydroelectric generation, the integration of the natural gas regulated assets in the TSO and the securitization of several energy tariff deficits. Invited professor at Catholic Law University in Lisbon, in Masters Studies, in the energy law area.

Author of several articles and publications on energy law, corporate governance, company law and capital markets.



#### Rui Pena

Rui Pena works in administrative law, focusing on public procurement, energy and environment.

Rui was the founding partner of CMS Rui Pena & Arnaut, and is now the current Senior Partner. He founded his first law firm in 1987.

He has been supporting several major companies within the Energy sector mainly in Public Law and Regulation matters related to Oil and Gas, and more recently to electricity. He has participated directly in the unbundling operation of the Gas companies and later in the internal procedures leading to the liberalization of the gas and electricity markets. He was President of the Law Firms Institute of the Portuguese Bar Association from 2006 to 2011 and was a member of the General Council of the Bar from 1987 to 1989.

Since 2011 he is a member of the Advisory Board of ASAP (Portuguese Law Firms Association).

In 1985 the Portuguese government asked him to bring together mediators and conciliators of the ICSID (International Centre for Settlement of Investment Disputes). Between 1976 and 1983 he was a Member of Parliament, and he was elected chairman of CDS Parliamentary Group.

Rui Pena was Lecturer of Administrative Law and Law of Obligations at Universidade Clássica de Lisboa and Professor of Administrative Law at Universidade Autónoma de Lisboa and Universidade Livre de Lisboa. He was also Professor of History of Political Ideas in the Instituto Superior de Línguas e Administração. Since 2011 he is a Guest Professor in the Master degree in Energy Law at Universidade Católica Portuguesa.

During the course of his career, Rui Pena has been Non-Executive administrator of several industrial and commercial businesses. Since 2010 He is President of the General assembly of EDP and member of the Supervisory Board of EDP.
